### **Objective of the Privacy Policy**

The Privacy Policy of the Securities Registry in the Federation of Bosnia and Herzegovina (hereinafter: Registry) according with the Article 14, Law on personal data protection of the BH (Official Gazette of FBH, 12/25 dated February 28, 2025) (hereinafter: the Law) is intended to provide a clear, complete and transparent information on the manner and the purpose of the data processing to all persons whose personal data is processed.

### **Purpose and legal frame for personal data processing**

Pursuant to the Article 2, Point o) Law on Securities Market of the Federation of Bosnia and Herzegovina (Official Gazette of FBH, 85/08, 109/12, 86/15 and 25/17) the Registry means a joint stock company that shall maintain a database in which data on securities are registered and kept, and that shall perform other securities operations according to the law.

The Registry shall process your personal data in accordance with the Article 8, Attitude 1, Point c) of the Law, exclusively to perform activities and authorisations prescribed by law.

Those activities and authorisations are, among other, registration, recording, maintaining and update of data securities, as well as the other activities prescribed by the Law on Securities Market, the Law on Securities Registry (Official Gazette of FBH, 39/98, 36/99, and 33/04), as well as the other active and general regulation issued by the Securities Commission of the Federation of Bosnia and Herzegovina.

### **What are your rights according to the personal data processing?**

Your rights according to the Law are:

- the right of access to personal data
- the right to rectification of personal data
- the right to erasure of personal data
- the right to restrict processing of personal data
- the right to data portability
- the right to object

### **Exceptions from the right to erasure personal data**

The right to erasure shall not apply if the data processing is necessary for fulfilling Registry's activities prescribed by law.

## **Transfer of personal data to other controllers**

The Registry could transmit personal data to other entities, institutions and authorities if necessary to fulfilling their legal obligations, as well as for fulfilling Registry's activities prescribed by law.

Transfer of personal data is made according to the Registry's obligations prescribed by the Rules on publications of information and reporting on securities market (Official Gazette of FBH, 99/22, 1/23, 12/23 and 100/23), and by the other applicable regulations.

Personal data can also be used by legal entities, Registry's members, according to the Law on Securities Market and the other related regulations, only for the purpose and in manner prescribed by law.

Personal data is not processed or transferred for direct marketing purposes.

## **Personal data security**

In its work, the Registry shall apply technical and organisational security measures that ensure protection against unauthorised access, use and processing of personal data.

The Registry shall process personal data in a manner to ensure protection and confidentiality of the data and to apply appropriate principles of lawful processing of personal data and reducing personal data quantity according to the principle of necessity.

The Registry has established appropriated organisational and technical measures, determined by the Data Security Plan in the Registry, No: 03-1931/23 dated February 23, 2023.

## **Personal data retention term**

Personal data is kept for as long as necessary to fulfil the processing data purpose. Once the processing purpose has expired, the data is stored and retained according to the archival operations regulation.

## **Privacy Policy changes**

The Registry shall perform regularly update of the Privacy Policy in order to provide accurate information. According to the principle of transparency, of any Policy changes the Registry shall issue a timely notice.
