Report on the Audit of the Financial Statements

To the Shareholders of Registry of Securities of the Federation Bosnia and Herzegovina

Opinion

We have audited the financial statements of Registry of Securities of the Federation Bosnia and Herzegovina (the Company), which comprise the statement of financial position as at December 31, 2024, and the statement of comprehensive income, statement of changes in equity and statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant information about accounting policies.
